### A RESOLUTION OF THE BOARD OF DIRECTORS OF THIS ASSOCIATION TO ELECT A SHAREHOLDER IN GOOD STANDING AS A DIRECTOR/BOARD MEMBER OF THIS ASSOCIATION.

**WHEREAS**, The Board of Directors of Leeds Domestic Water Users Association, (“LDWA”), has previously taken action by written consent through email communications without a formal meeting of its Directors; and

**WHEREAS**, the LDWA Bylaws ARTICLE IV, Board of Directors, Section 2. Term of Office – Qualifications provides that the Board of Directors shall have the power to appoint directors to fill any vacancies as soon as practical thereafter. Appointed directors shall hold office for the remainder of the two-year term as though they had been elected.  
[Amendments to Bylaws, February 2, 2016]; and


**WHEREAS**, the LDWA Bylaws ARTICLE IV, Board of Directors, Section 3. Removal provides that the Board in the event of death, resignation or removal of a Director, a temporary successor shall be selected by the remaining members of the Board and shall serve for the unexpired term of his/her predecessor. [Bylaws, March 4, 1995]; and

**WHEREAS**, the LDWA Bylaws ARTICLE IV, Board of Directors, Section 6. Vacancies provides that a vacancy in any office may be filled by appointment of the Board. The officer appointed to such a vacancy shall serve for the remainder of the term of the officer he/she replaces.  
[Bylaws, March 4, 1995]; and

**WHEREAS**, it is in the best interest of this Association that the Board of Directors exercise such appointment of a director to fill the vacancy created by the resignation of Aaron Bateman (Board Member elected February 1, 2022) to this Association.

### BE IT HEREBY RESOLVED THAT:

Alan Cohen, an LDWA Shareholder in Good Standing with the Association, is duly elected by email votes attached to this Resolution and confirmed to the Association’s Board of Directors as a director/board member for this Association, effective the 18<sup>th</sup> day of April 2022.
