## WATER METER INSTALLATION APPLICATION - New Home Construction -

**NOTICE:** Property owners are required to own one culinary Water Share with LDWA. All requirements herein must be satisfied prior to commencing construction, excavation, digging, installation of septic system. LDWA does not guarantee timely culinary water service to the parcel if the terms of this application are not completed.

**DOCUMENTATION.** Property owner or designee shall submit to LDWA one (1) copy of this completed application and the following addendums in electronic form:

1. Recorded and approved Building Permit issued by the Town of Leeds.
2. Approved Septic Report/Letter of Feasibility, a copy of the Septic Permit issued by the Washington County Health Department, Southwest Utah Public Health, including location and placement for septic and leach lines.
3. Engineering drawing identifying locations of all Utility Easements on the parcel.
4. Property Deed recorded with Washington County, Utah.
5. Proof of Blue Stakes notifications prior to commencing excavation or digging.

**FEES.** Property owner shall pay Impact Fees, Water Connection, and any other fees as currently required for new home construction to LDWA. (Refer to Rate Schedule.)

**SCHEDULE.** Installation of a water meter is approximately five (5) to ten (10) business days from approval of completed application. Some systems may take additional time and review; any additional costs will be paid by the property owner.

LDWA's authorized agent shall review documentation to ensure LDWA culinary water lines are identified. The property owner acknowledges the location and need for access to the Utility Easement(s).
